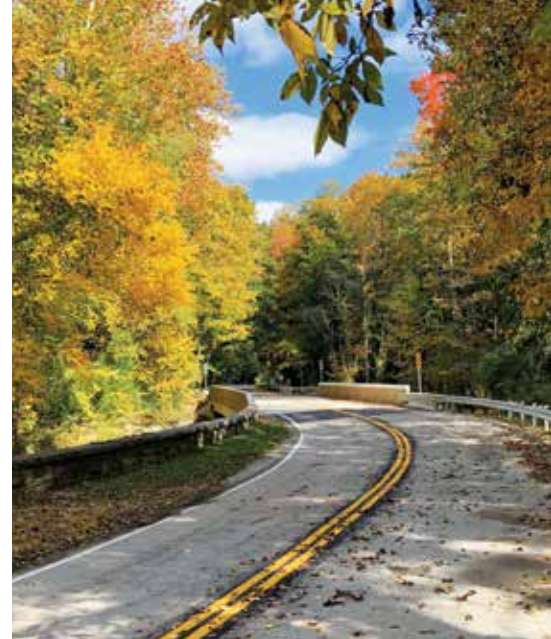
You may have recently noticed increased activity from our coyote population. I know that some of our residents continue to be concerned about their presence. To that end, I recently attended an Urban Coyote webinar that I found to be incredibly informative. We have posted the link to this presentation on our website and Village Facebook page. As we were advised by our good friends at the Ohio Department of Natural Resources this past year, these animals are here to stay and our best effort is to become better educated as we continue to coexist with our coyote population. As a cat owner (four of them), I share some of the concerns related to the safety of our pets. However, concerns for personal safety are not typically supported by data and this presentation reinforced the fact that coyote attacks on humans are very rare. However, there are some steps we can take to keep our pets safe and some of these practices are detailed in the presentation

I referenced earlier. Residents can also contact my Administrative Assistant Sherri Arietta who can provide notes from our meeting this past year with ODNR experts. Lastly, we have several copies of *Coyote America* by Dan Flores available for those interested. This book documents the behavior of these animals and also takes a look at the cultural evolution of the American coyote.

Last month I had the honor of attending the wreath ceremony in honor of President James A. Garfield. Our Village is fortunate to share in the history of this man. Since he was born in Moreland Hills, the day started with some brave souls who hiked from the birth site on our campus all the way to Lakeview Cemetery. Along with Council President Steve Richman, I attended the ceremony at Lakeview and was impressed at the pageantry and the beauty inside of the Garfield Monument. If you have never visited this site, I highly suggest that you add it to your list of places to see. Special thanks to Moreland Hills resident Maureen Geck and the Moreland Hills Historical Society who work so very hard to keep the legacy of this President alive. TREE DONATION FOR VILLAGE PARK

Our wonderful pavilion and the land at Forest Ridge Preserve has grown out of a partnership that involves our entire community. In keeping with this spirit, we are looking for interested parties to help increase the number of trees in Village Park.

We are looking for 10 residents who would be willing to buy a live (ball and burlap) Christmas tree this year that can be re-planted at Forest Ridge Village Park once the holidays are over. Any type of evergreen is acceptable and it should be at least 4-5 feet in height.

These trees can typically be purchased at any of the local Christmas tree farms in the area; one such farm is Sugar Pines Farm www.sugarpinesfarm.com. They will provide you with an instruction sheet for proper care of your tree so that it will be viable after the holidays. If you choose to buy your tree from them, please consider going during the week, as the weekends get very busy.

After the holidays, our Service Department will come to your home and pick up your tree, which will then be planted in the area surrounding our new pavilion.

ORDINANCES & RESOLUTIONS

The following Ordinances and Resolutions were passed in November:

Ordinance 2021-49 – authorizes Change Order No. 1 with Jadco Construction Services, Inc. for the patching and painting of the Miles Road Retaining Wall for an increase of \$38,847.25, which is a result of additional work necessary to complete the project.

Ordinance 2021-50 – authorizes Change Order No. 1 with Terrace Construction Co. for the 2021 Drainage Program, for an increase of \$1,542.67, which is a result of additional work necessary to complete the project.

Ordinance 2021-51 – authorizes Change Order No. 3 with Carron Asphalt paving, Inc. for the Forest Ridge Preserve Pavilion – Contract B Site Work for a decrease amount of \$9,907.22, which will reconcile and close out the contract.

Ordinance 2021-52 – amends Section 141.01 “Composition,” of the Codified Ordinances to authorize the Mayor to appoint full-time patrol officers to ensure appropriate staffing levels in connection with anticipated vacancies, for further protection of public peace, health, safety, and welfare.

Ordinance 2021-53 – authorizes the donation of the Village Police in-car digital video recording devices that are no longer needed, to the Village of Convoy, Ohio who are in need of the devices.

Ordinance 2021-54 – authorizes the Mayor to enter into a contract with Guardian Life Insurance Company of America for the provision of Life Insurance and Accidental Death and Dismemberment Insurance to Village Employees for 2022.

Ordinance 2021-55 – authorizes the Mayor to enter into a contract with Medical Mutual for the provision of Health Care Insurance to Village Employees for 2022.

Ordinance 2021-56 – authorizes the Mayor to enter into a contract with MetLife for the provision of Dental Coverage to Village Employees for 2022.

Ordinance 2021-57 – authorizes the Mayor to enter into an agreement with the Auditor of the State of Ohio to compile annual financial statements for the year 2021 and issue an accountant report thereon.

Ordinance 2021-58 – an appropriations ordinance, which is a monthly financial housekeeping item.

Ordinance 2021-59 – amends Section 153.02 of the Codified Ordinances, “Paid Holidays,” to modify the schedule of paid holidays when Christmas Day falls on Saturday or Monday and to authorize the Mayor to modify that schedule when New Year’s Day falls on Saturday. **Placed on First Reading**

Ordinance 2021-60 – enacts new Chapter 161, “Diversity and Inclusion Commission,” of the Codified Ordinances to establish the Moreland Hills Diversity and Inclusion Commission and prescribe its responsibilities and organizations. **Placed on First Reading**

Resolution 2021-61 – approves the petition for special assessments for special energy improvement projects under Ohio Revised Code Chapter 1710 and approves the necessity of acquiring, installing, equipping, and improving certain public improvements in the Village of Moreland Hills in cooperation with the Northeast Ohio Advanced Energy District.

Ordinance 2021-62 – determines to proceed with the acquisition, installation, equipping, and improvement of certain public improvements in the Village of Moreland Hills in cooperation with the Northeast Ohio Advanced Energy District.

Ordinance 2021-63 – levies special assessments for the purpose of acquiring, installing, equipping, and improving certain public improvements in the Village of Moreland Hills in cooperation with the Northeast Ohio Advanced Energy District and authorizing an energy project cooperative agreement and a special assessment agreement (34555 Chagrin Blvd.).
