We are simply defining areas where a heavy presence is reported so that we can direct message neighborhoods with techniques used to discourage these animals from entering one's property. This data may also be used in the event that we need to seek advice from the local experts at the Ohio Department of Natural Resources. We have thoroughly researched the issue and met with local and national experts. We can now share this information with interested residents. The coyote sighting form can be submitted electronically and is found on our Facebook page and Village website. The form also includes some

suggestions related to dealing with our local coyote population.



COYOTES

Residents may have noticed an increased presence of coyotes in their yards lately. Mating and birthing months of the coyote encompass January, February, and March each year. While coyotes tend to be more protective and territorial during this time, please be aware that attacks on humans are incredibly rare. Attacks on pets, however, can occur but you can take steps to prevent coyotes from entering your yard, such as:

- Eliminating outdoor pet food, cleaning the grill area including the grease tray, and avoiding garbage cans being stored outside when an indoor (garage) option exists.
- Consider using a tray under your bird feeder to eliminate seeds from dropping on the ground.
- Take your pet out on a leash; coyotes can scale fences.
- Employ hazing techniques when you see a coyote on your property. The most common technique is to make yourself appear larger by waving your arms above your head and yelling at the animal.

Safe practices with pets should take place yearround, as culling or thinning the presence of coyotes is an exercise in futility. If, however, a coyote appears to be aggressive or dangerous, residents can hire a nuisance trapper. Please be aware that trappers can be expensive and the snare method used can be quite painful and inhumane for the animal. The goal is peaceful cohabitation and NOT removal of the animal.

The Village is providing a Coyote Sighting Report Form (the link is available on our website and Facebook page) in an effort to document the prevalence and concentration of coyotes within our borders. This information can then be used for direct messaging purposes and to mitigate any issues that requires attention, such as the presence of a defined nuisance animal. Please do not call our Police Department to report a sighting, but use the form instead. Our officers are not able to put the animal down, unless of course it is severely injured.

ORDINANCES & RESOLUTIONS

The following Ordinances and Resolutions were passed in December:

Ordinance 2022-01 – authorizes the Mayor to enter into an agreement with Walter|Haverfield LLP from the January 2022 Organizational Meeting through the January 2023 Organizational Meeting, for general legal services and to engage William Hanna as Law Director and R. Todd Hunt as Legal Counsel for the Board of Zoning Appeals and Planning Commission.

Ordinance 2022-02 – authorizes the Mayor to enter into an agreement with Chagrin Valley Engineering, Ltd. and Jeffrey J. Filarski for Village Engineer Services for 2022.

Ordinance 2022-03 – provides for the continued employment of Santo T. Incorvaia as prosecutor, fixing compensation.

Ordinance 2022-04 – authorizes the Mayor to enter into a Memorandum of Understanding with the Cuyahoga County Board of Health to provide Phase II Stormwater Services in 2022-2025, relating to illicit discharge detection and elimination programming and pollution prevention/good housekeeping assistance.

Ordinance 2022-05 – authorizes the Mayor to enter into an agreement between Cuyahoga County Juvenile Court, Cuyahoga County and the Village of Moreland Hills for participation in the Juvenile Court Community Diversion Program for 2022-2023.

DEER MANAGEMENT PROGRAM

The Cleveland Metroparks will be continuing their Deer Management Program this winter in a portion of the South Chagrin Reservation. Portions of the South Chagrin Reservation will be closed to the public on several days from January 18 through March 17, 2022, from Noon to 6:00am the following morning.

Safety remains the number one goal of the Cleveland Metroparks. Signage indicating that the reservation will be closed completely during the management program will be posted. In addition, residents who own property adjacent to the Cleveland Metroparks Property will be sent a letter informing them of the program.

Specific closures will be posted on the Cleveland Metroparks Alerts and Closures page by 6:00pm on the evening prior to an area's closure. https://clevelandmetroparks.com/parks/visit/alerts-closures

Cleveland Metroparks has worked hard to ensure that the deer management program is safe, humane, and effective. As in past years, venison will be donated to a local food bank.
