STUDENT CIVIC LEADERSHIP PROGRAM

The Village of Moreland Hills is seeking one Moreland Hills resident who is a current high school student graduating in the class of 2025 to join its Parks, Green, and Diversity and Inclusion Commissions. These commissions are tasked with important work, such as preservation, recycling, and representation. The student selected will serve for two years as a full voting member of these commissions, with their input equal in weight to all other members. In year one, the student will be a member of the Green Commission and Diversity and Inclusion Commission. In year two, the student will be a member of the Parks Commission. Commission members attend commission meetings, discuss their opinions, help plan events, and cast their votes. Additionally, the selected student will have the opportunity to meet with the Village Mayor, Council President, and department heads.

Eligibility: You must be in the graduating class of 2025 and you must be a Moreland Hills resident. The selected student may choose to begin their term in either Summer of 2023 or at the start of the 2023-24 school year.

To apply: Email a maximum two-page essay to villagehall@morelandhills.com answering the following question: "Over the next 10 years, how will you improve the communities in which you live?" The following information should be in the body of your submission email only: name, address, email, phone number, school, and graduating class. Essays will be scored without knowledge of the identity of the applicant, so please do not put any identifying information in your actual essay, as that information will not be made available to those scoring them.

The deadline for submittal is May 15, 2023. Selections will be made in June 2023. We look forward to your input!

THE FOLLOWING ORDINANCES AND RESOLUTIONS WERE PASSED IN APRIL:

Ordinance 2023-15 authorizes the Mayor to enter into a purchase agreement with KTS Equipment Inc. through Sourcewell Cooperative Purchasing Program for one wood chipper for the Service Department, for a price not to exceed \$69,104.80 including a trade-in option.

Ordinance 2023-16 authorizes the Mayor to purchase one 2023 Ford F-150 Police Responder vehicle for an amount not to exceed \$47,341.00.

Ordinance 2023-17 authorizes the Mayor to enter into a contract with Crossroads Asphalt Recycling, Inc. or the 2023 Asphalt Pavement Program, in the amount of \$847,355.10.

Ordinance 2023-18 authorizes participation by the Village in the ODOT Road Salt Contract awarded in 2023, for the 2023-2024 winter season.

Ordinance 2023-19 authorizes the Mayor to "opt-in" to national opioid settlements to resolve opioid litigation against Teva, Allergan, CVS, Walgreens, and Walmart.

Ordinance 2023-20 an appropriations ordinance, which is a monthly financial housekeeping item.

Ordinance 2023-21 an ordinance amending Ordinance 2023-18 authorizing participation by the Village of Moreland Hills in the ODOT Road Salt Contracts awarded in 2023 and declaring an emergency.

COMING EVENTS

Chipping Week – May 15-19

The Service Department will chip branches and sticks on your street. The branches should be cut into 4-foot lengths and stacked, in small bundles, facing the same direction; they DO NOT need to be tied. Piles with crisscrossed branches and anything over 5 inches in diameter WILL NOT be chipped. THIS WILL BE STRICTLY ENFORCED. Please have the bundles stacked by the side of the road by 7:00am on May 15; the Service Department will chip them over the entire week. Please note: per Village Ordinances, the first 15 minutes will be provided without a charge. Any additional time needed for chipping will be charged at a rate of \$30 for each 15 minutes over the allotted time.

Greening the Hills – May 20

Greening the Hills will be held on Saturday, May 20, from 9:00am to Noon at Village Hall. Bring your hazardous waste, paper for shredding, electronics, scrap metal, tires, and oil-based paint to be properly disposed. Employees and volunteers will be on hand to take the items out of your vehicle as you drive through our campus.

Memorial Day – May 29

Village Offices will be closed on Monday, May 29. There will be no Special Pick-Ups or Yard Waste Pick-ups that week. Any Monday Rubbish collections will be done on Tuesday.

INFORMATION ABOUT NOPEC

Eligible residents and small business owners will be receiving natural gas and electric enrollment letters for our community's energy aggregation programs through NOPEC.

Letters began mailing in early April for enrollment in the NOPEC electric program and mid-April for natural gas for the period beginning with customers' June 2023 meter read dates.

If you want to enroll in NOPEC's Standard Program Price, you don't need to take any action when you receive your enrollment letter. **You will automatically be enrolled.**
